REGULAR MEETING OF COUNCIL - MAY 14, 2024

A Regular Meeting of Council was held on May 14, 2024 at the County of Vermilion River Administration Office in Kitscoty. Council approved the following resolutions:

APPOINTMENTS

Council met with Northern Lights Library representative James MacDonald; Onion Lake RCMP Adam Olson; Kitscoty RCMP Sgt. Mark Cusack, Vermilion RCMP Sgt. Corey Buckingham and ATCO representatives Joe Slater, James Guthrie and Samantha Tawkin regarding the ATCO Kitscoty Wind Project.

Public Hearing for BYLAW 24-09 Land Use Bylaw

Council held a Public Hearing regarding Bylaw 24-09 Amendment to the Land Use Bylaw (Bylaw 19-02).

Michener Allen Auction of three graders

Council received information regarding the sale of three graders for a total amount of \$355,500.00 after commission from Michener Allen Auctioneering Ltd.

Contract for Fuel Services

Council awarded the contract for Fuel Services for Bulk and Cardlock locations to Cornerstone Co-operative for a three-year term with the option to extend for two additional one-year periods.
