KEY RESPONSIBILITIES

- Oversee the approval and inspection of overweight hauls to ensure compliance with permitting system and the County traffic bylaw
- Authorize and execute road use agreements as required
- Collaborate with industry on road issues, potential partnerships for road improvements and dust suppression on industry use roads
- Regularly meet with industry operators to review agreements, haul routes and other emergent issues
- Advise industry of any infractions, problems and/or concerns on behalf of the County as they relate to operations and assess road impacts or concerns associated with industry
- Promote positive working relations between the County and the energy sector
- Provide leadership and guidance to Industry on County-related matters
- Coordinate the approval, inspection, and issuance of necessary permits
- Assist in preparing standards and procedures, performing inspections on haul routes, access roads & approaches, pipeline installations & road crossings and approach approvals
- Approval and inspection of oil rig moves within, into and out of the County
