Council approved the 2024 additional funding for libraries local to the County of Vermilion River as presented and budgeted.

#### PRIVATE SALE AND RENTAL OF RESIDENCE AT NE-35-50-3W4M

Council approved listing the residence at Lot 2 Block 2 Plan 9521666 within Pt. NE-35-50-3W4M privately for the price of \$525,000.00 plus GST.

Council approved renting out the residence at Lot 2 Block 2 Plan 9521666 within Pt. NE-35-50-3W4M at a competitive rate of \$2,300.00 per month that includes utilities (limited to natural gas and power) and insurance cost until such time as the property has been sold.

#### **BYLAWS**

Council passed Bylaw 24-21 Schedule A Amendment to Bylaw 21-22 Scale of Fees for Water and Sewer Utilities as presented.

Council passed Bylaw 24-20 Water and Wastewater Utility System Control Management as amended.

#### **COST OF LIVING ALLOWANCE 2025**

Council approved a 2.93 per cent Cost of Living Allowance increase based on the consumer price index for Alberta, for the last 12 months, averaged in October for all staff except the Chief Administrative Officer and those employees red circled, effective the first pay period of 2025.

Council approved no Cost-of-Living Allowance increase for 2025 for members of Council.

Council approved the 2025 rate of pay for the Chief Administrative Officer at \$210,000.00 plus Cost-of-Living Allowance of 2.93 per cent plus additional one week vacation effective the first pay period of 2025.
