The County of Vermilion River is seeking three (3) highly motivated individuals to join our safety-oriented team as Vegetation Management Applicators. Join our Agriculture team for the summer and be part of a fun and energetic team focused on improving agriculture sustainability! This position will help with vegetation management through inspections and control as an Alberta Pesticide Authorized Assistant, as well as assist in sustainable agriculture initiatives throughout the County. This position is based out of Kitscoty, Alberta.

KEY QUALIFICATIONS

- Must be enrolled in and returning to post-secondary education in agriculture, environment or a related field and have an agricultural background.
- Familiarity with general cropping practices in our region and ability to identify a wide range of weeds and crops.
- Professional manner with the ability to communicate effectively.
- Ability to do manual labour, work outdoors in all weather conditions and lift to 50 lbs.
- Have a valid Class 5 Driver's License and acceptable Driver's Abstract.
- Hold or be able to obtain an Alberta Pesticides Authorized Assistant Certificate.

KEY RESPONSIBILITIES

- Conduct Vegetation Inspections by identification, mapping, and utilizing GIS to record concerns, of prohibited and noxious weeds.
- Control weed infestation through herbicide application, manual and mechanical weed control
- Assist in Agriculture Pest Surveillance for insects and diseases including clubroot inspections, rat control, bertha armyworm counts and grasshopper surveys.
- Assist with the Agriculture Plastic recycling programs.
- Support for Agriculture Sustainability programs includes ALUS, environmental conservation programs, workshops, and educational opportunities for County Ratepayers.

This position will tentatively start on May 5, 2025, and conclude on August 29, 2025 (these dates are subject to change). A competitive wage is available. The successful candidates will be required to provide a criminal record check and drivers abstract.
